Lynn was seconded from Clapton to Linklaters (a city based global law firm) in 2007 to set up a 'Realising Aspirations' community investment strategy which focused on raising achievement and aspirations for young people in Hackney. This award-winning programme has now been introduced as part of the global strategy for Linklaters. While remaining part of the Corporate Responsibility Team at Linklaters, Lynn is now semi-retired although she retains responsibility for the firm's Work Experience programmes for Hackney and, since 2016, for Haringey.
